About the Bulldog Pride Fund

Founded in 2005 and officially recognized in 2006, the **Bulldog Pride Fund** (BPF) is an endowment that provides an annuity to support student scholarships at Fresno State.

The BPF is maintained under the auspices of the Fresno State Alumni Association, a non-profit 501(c)(3) organization recognized by the Internal Revenue Service.

The BPF is administered by the Scholarship Office, Division of Student Affairs. The scholarship criteria are that a Fresno State "student(s)" have "good academic standing" and have "demonstrated pride in the community."

Donations are deposited into an endowment account that is invested in a diverse portfolio with the assistance and guidance of Merrill Lynch. Annual earnings (interest) of the BPF are used to fund scholarships, while the principal continues to earn interest in perpetuity for future scholarships.

The BPF accepts cash, checks and credit cards. The BPF also welcomes gifts such as securities, real property, corporate matching gifts and bequests.

BPF donations are tax-deductible to the full extent of the law. A donation made today will give — in some capacity — tomorrow and beyond.
